TOWN OF FINE APRIL 6, 2022

A joint town board meeting with the Towns of Clifton and Fine was held on Wednesday, April 6, 2022, at the Clifton-Fine Community Center in Star Lake . A quorum of both boards was present. The meeting was called to order by Supervisor Hooven at 6:30 PM.

Senior Citizens – John Burns, acting on behalf of the Clifton-Fine Senior Citizen's Club was present to request that both boards consider putting money in their 2023 budgets for the senior citizens. He understands that other towns do this under Adult Recreation in their general fund under account code A72604. They are looking for help to pay for bus trips for the club. Motor coaches are what they would like to use, as school buses are getting too hard to get into and uncomfortable. These coaches are very expensive. Both supervisors thanked him for coming and presenting. Supervisor Hooven suggested that the club produce a budget and a figure in mind to present to both boards. The towns start working on their budgets in September. John said that he could have something to both boards before then.

Golf Course - Pat MacKay had several questions about the running of the golf course.

Golf Course committee members encouraged him and anyone else who has questions regarding the running of the golf course to attend the golf course committee meetings.

Financials – The current cash for the golf course as of February 2022 is \$28,409.00. The Water Fund balance is \$4,440.00.

Dates for opening – The golf course committee has set the start date for the grounds crew to be April 25th and to open the clubhouse on May 2nd. This is subject to change based on the weather conditions.

J. Russell, seconded by K. Kerr to authorize the hiring of Brady Hall to work in the clubhouse at minimum wage.

Driving Range – The person(s) who will take care of the driving range will be determined by the golf course committee at a later date.

Update – Cheryl gave a brief update on things that the committee has been working on. They will be moving the half wall in the kitchen area forward to allow more room for the workers and a meat cart. By moving this wall forward, they do not need to remove the ladies' room.

Scorecards – Businesses have purchased space on the scorecards for advertising this year. This has worked well and has brought in over \$1,000 for the golf course.

Friends – The Friends of the Golf Course purchased stones for around the flagpole. The committee is very appreciative of their help around the golf course. They are working on raising funds to purchase another mower.

Thanks – The Committee also wanted to thank both boards for their continued support of the golf course.

Improvements- The committee will discuss improvements to the course with Gary once the course is open.

Driving Range – There was damage at the driving range building. This has been reported to the insurance company and the adjuster will go there as soon as weather permits.

Mower – Due to supply chain issues, the new mower will not be here until June.

Arena Financials – The current cash on hand for the arena as of February 2022 is \$44,368.54.
