- Bulldozer Kelly discussed his current dozer year and what it needs to fix. Can't find one in the budget already approved. Found a 2009 Cat D5K XL tractor, comes with sprockets and chains. Can't afford to pay for with amt budgeted so set up a lease option. See Quote dated 4/13/22. Kelly says because it is a lease purchase we don't have to go out for bid, it is used and not on state contract.
- Motion to purchase 2009 Cat D5K Tractor with a lease over 4 years with \$1 buy out was made by M.
   Zuhlsdorf with a 2<sup>nd</sup> by J. Russell

NF - mess uptown - sweeping - Cars and garbage

- · Kelly wants to somehow make it so during the winter and sand sweeping the street to be clean. Lawyer sent us some sample law that we can look at to adopt. Asked if they could be ticketed. Need to look at a law. Will dig out the samples and look at.
- A couple of instants on Columbian road with trucks on the roads while it is posted. Worried about favoritism. If someone goes up and breaks the road that person is responsible for fixing. Chuck says he should be putting in the bargain hunter.
- Screening plant motor has been sent.
- · Started sweeping roads
- December board meeting announced Terry Wendt was retiring, and we would look at hiring in May. Kelly proposed that 2 of his guys would take over the sewer dist. if they let him hire this next man. Would

like to send 2 guys to learn how to rebuild the grinder pumps, 1 is willing to go to school if town would pay for it. Talked about how much time each man gets for vacation and comp time. He feels he needs the manpower. Doesn't mind taking on more work to justify all 6 men. John told he can't do the 2 men in the sewer plant they need 1 year experience to get a license. They can learn how to rebuild the pumps. Chuck said he doesn't have the power to tell him what to hire or fire, however they had a plan to reduce to 5 men on attrition. Kelly wants them to know what he does may not be able to get done. Moe stated there has been lot of things added to what the men do. Kelly said at times he doesn't have enough men to flag. Kelly stated they are not just a highway department, that they always do what they are asked. Kelly brought up that they get paid \$46000 a year from the county road plowing and he feels that is almost the salary of a man. John mentioned that in 2012 they let Butch Pelo go and hired 1/2 a man to be laid off in the spring. Why is it not ok now? Kelly stated that he needs to know if he's getting a 6-man crew or if keeping to 5 1/2, if so, things will change.
