ii. Maintaining the condition tees for the ladies to use is important.

iii. The general consensus is that the banishment of men on the "forward" tee should only be temporary until the tees can be enlarged to accommodate the number of users wanting to use them.

iv. All agreed that anyone with a physical handicap should be allowed to use the forward tees as they have been.

v. Dave spoke with Gary to look at the process of doing that, may need to ask the highway department for road sand to use for the base and get some top soil to cover.

vi. Will ask the tee committee to evaluate position of temporary "sr" tee markers and identify priorities to begin enlarging the tees.

1. Suspect 4, 8 & 16 need to be on the top of the list as these are the tees that are being severely torn up.

vii. To do this correctly and quicker we will need more funds than what was budgeted, this might be a good place for friends of the golf course to be involved.
