- Section 3: Mandatory Referendum. This Local Law is adopted subject to a Mandatory Referendum and shall be submitted for approval of the qualified voters of the Town of Clifton at the General Election to be held on November 5, 1996. A proposition in the following form shall be included in the ballot at such General Election and the increased term of office shall not take effect until after January 1, 1997 and only upon such proposition being approved by the majority vote of the qualified voters voting thereon.
