PUBLIC COMMENT:

• <u>K. Provost</u>

wants to know what can be done about the properties that are overrun with junk cars, boats and garbage in Newton Falls and Star Lake. The Town has roughly set aside \$20,000 for cleanup of properties, possible proposal of taking a period where we would have the Highway Department, along with the landowner clean the properties up and take unwanted items to the transfer station. Our code enforcement officer is working to see how we can enforce this. We can move forward from there with a new local law that has some teeth in it. C. Hooven is working with the town lawyer to develop a new local law for property clean up.

 $_{\odot}\,$ When will be have a dog census? C Hooven said that we will put the money in the budget for next year. In the meantime, an add will be placed in the Bargain Hunter to have your dogs licensed.

• <u>N. Nolan</u>

 $_{\odot}\,$ Concerned about the LaFrance property being in ruins and the barge that is now sitting on the bottom of the lake. Again C. Hooven is working with the town lawyer on an updated law.

• <u>M. Zimber</u>

 $_{\odot}$ Door in the basement of the community room is awesome. Friends of the Library will not have a book sale this year due to lack of books. She would like permission from the town to put up tables through the summer in the basement of the community center with books on them for sale by the honor system. The Board had no problem with this.

• <u>L. Denesha</u>

 $_{\odot}$ Covid 19 – Monday, June 6th totals were 91 new cases, 5 hospitalized. The positivity rate for the county is at 3.6% and 7.12% for the state. Right now, the transmission level is at Low.

- $_{\odot}\,$ Tax collections have increased, 2015 it was 88.84%, 2018 90.87%, 2021 92.6%
- $_{\odot}\,$ There has been a 10% increase in the price of asphalt
- Edwards-Knox now has a School Resource Officer

 Passed a resolution to do a 6-month feasibility study in St. Lawrence County of the sludge that comes from the wastewater treatment plants. The sludge that goes to the landfill will be dried and turned into Class A fertilizer. $_{\odot}$ Superintendent Smith asked how come the Town of Louisville receives more money from the county then anyone else? L. Denesha will investigate it.

 \cdot Updated Dog Report, put ad in bargain hunter with the rules for licensing your dog in the Town of Clifton. A dog census will be budgeted for 2023
