iv. Spoke with Cheryl her concern for the ladies is that the short holes are being chewed up when the men use irons. Where ever the placement of the sr. tee post are placed does not affect the lady golfers.

v. Would like a group of 5 or less to make recommendations, Pete Guiles was suggested as a possible participant.

b. We will have to bring this to the joint town boards because they must approve changes to the golf course, not so much developing temporary forward tees but enlarging the current ladies tees, including the making the alternate ladies tee on number 3.

F. Parking for Staff, discussed with Mandy and she is concerned her car couldn't get over the curb, I think we should begin next year with the expectation that the front of the building would be left open for Jreck "customers".
