Special Rate: 11/2013-189 " . . . adopt a special weekday rate of \$20.00 for 18 holes with a cart prior to Memorial Day and after Labor Day each year, tournaments excluded."

Amend Policy -10/2022-139 Moved by W. Powers, seconded by P. Giardino to amend the Policy and Procedures for the golf course as recommended by the golf course committee.

Discussion: Changes to Golf Course Policies and Procedures

IV Policies: 2. Fees d. Add "1st TIME INDIVIDUAL is an individual who has never before been an adult member of the course.

Add IV Policies: 2. Fees i. Gift Certificates are available for sale.

Add: IV Policies: 2. Fees j. Rates established by the committee (and approved by the joint Town Boards) each year supersede any rates/language from previous years.

Change: VI TOURNAMENT RULES: 2. Riding carts are available for rent from the course.

Anyone using a private cart must have already paid the annual trail fee for it if the cart is their own or pay the borrowed cart fee if using a cart personally borrowed from someone else who has already paid the annual trail fee. Notwithstanding, all carts provided to/by the course will require full cart rental fee.

Dates – The start and end dates for the golf course are 4/24/2023-10/22/2023 for the grounds and 5/1/2023-10/15/2023 for the clubhouse.

Community Center- Jeremy will see about getting the vinyl siding that was damaged in the car accident replaced, the outside lighting fixed, and replacing the back door that is broken. Dog Control – 10/2022-146 Moved by P. Giardino, seconded by K. Kerr that the Towns of Clifton and Fine enter into an Animal Sheltering Services Agreement with the Potsdam Humane Society for 2023 at a cost of \$1,800.00 to be split evenly by both towns.

Youth Commission – 10/2022-147 Moved by P. Giardino, seconded by K. Kerr to approve the 2023 Youth Commission Budget as presented and that each town contributes half of the actual expenses up to \$6,406.00 each.

Senior Citizens – Members from the Senior Citizen's club were present to ask about their request for funds to help with busing to events from both towns. Both Supervisors said that the \$1,500 requested from both towns was in their budgets and should be approved.

ARPA Funds – There was a discussion on ARPA funds. Clifton has spent their funds on their sewer district. The Star Lake Fire Department sent a request for funds to help start up a Jr. Firefighter Program. Chuck explained that their ARPA funds have been spent and that if taxpayer money was going to be used to start up this program, it should come from the fire district.

Derelict properties – There was a brief discussion on derelict properties and cleaning them up.
