Section 1. Legislative Purpose and Intent. Due to increasing costs of publishing, the Town Board of the Town of Clifton feels it is necessary to provide an alternative notice requirement for Local Laws rather than full publication of each law.

Section 2. Law. The Town of Clifton shall publish an abstract of any Local Law which is passed rather than the text of said Local Law as required by Town Law Section 264. Said abstract shall be published after passage of Local Law. The abstract shall contain the title of law and a brief statement of its coverage or purpose. Said abstract shall also contain a statement that the full text of law is available for examination at Town Clerk's Office. Said abstract shall also contain a statement that a copy of the full text may be obtained at the Town Clerk's Office by paying appropriate copy fee.

Section 3. Authority. The authority for this law is Municipal Home Rule Law Section 10 (subdivision 1, paragraph [i]).

Section 4. Effective Date. This law shall become effective upon passage by the Town Board, property publication, and filing with Secretary of State.

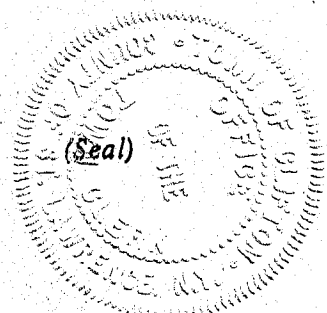
