Local Law No. 1 of the year 2010

A local law regarding the use of Town Highways by All Terrain Vehicles

Be it enacted by the **Town Board** of the Town of **Clifton** as follows:

- PURPOSE. The Town Board of the Town of Clifton finds that the use of Town Highways by All Terrain Vehicles would promote the economic interest of said Town. Therefore, the Town is desirous of opening up the following Town Roads to the use of All Terrain Vehicles. The River Road and Tooley Pond Road from the Newton Falls Town Limits to the Cranberry Lake Town Limits; Also the Newton Falls Hill (from the River Road Junction to the bottom of the Paper Mill Hill Bridge); Also the Golf Course Road in Star Lake; Also Columbian Road in Cranberry Lake.
- Section 2. <u>AUTHORITY.</u> This Local Law is enacted pursuant to the provisions of Article 48-C of the Vehicle and Traffic Law.
- Section 3. TITLE. The title of this Law should be "The Use of Specific Town Roads by All Terrain Vehicles".
- Section 4. <u>DEFINITIONS.</u> As used in this Local Law, all words shall be defined as defined in Article 48-C of the Vehicle and Traffic Law.
- Section 5. (1) It shall be legal for all All Terrain Vehicles properly licensed and registered under Article 48-C of the Vehicle and Traffic Law to operate on the following specific roads situated in the Town of Clifton: The River Road and Tooley Pond Road from the Newton Falls Town Limits to the Cranberry Lake Town Limits; Also the Newton Falls Hill (from the River Road Junction to the bottom of the Paper Mill Hill Bridge); Also the Golf Course Road in Star Lake; Also Columbian Road in Cranberry Lake.
 - (2) Said vehicles shall be operated only by licensed operators over the age of eighteen years.
- Section 6. <u>EFFECTIVE DATE.</u> This Local Law shall be effective immediately.
